

AHISD 24 Hour Code of Leadership (junior school)

The purpose of this Participation/Commitment Form is to communicate to students participating in extra-curricular/co-curricular activity and their parent/guardians, minimum additional expectations of non-school related conduct for continued participation. The opportunity to participate in extra and co-curricular activities is a privilege often placing students in a position of public recognition. Students involved in these activities may also serve as role models. Thus, while all students are subject to rules of conduct under the High School Discipline Plan, the Student Code of Conduct, and the laws of the State of Texas, with the privilege of participation in extra-curricular/co-curricular participation comes the following added responsibilities and expectations:



Students who participate in extra-curricular and co-curricular activities in the High School or Junior School will be held accountable by the respective sponsors' rules and guidelines of the respective organizations and activities for behavior occurring outside of the school setting.

Participants in this extra-curricular/co-curricular activity and their parents/guardians, agree to abide by both this form, and the policies, constitutions, other regulations, guidelines of the activity or organization, if any, (hereafter referred to as "Constitution" for consistency and clarity) as now existing, or as may be otherwise amended and communicated.

Students who participate in an extra-curricular/co-curricular activity, if found by school officials to have committed any act related to alcohol, drugs, hazing, violating academic integrity, or any conduct described in the Student Code of Conduct, which conduct is punishable as a felony or misdemeanor, regardless of disposition by the judicial system, will be suspended from this extra-curricular/co-curricular activity for at least ten (10) school days if self-reported; and otherwise a minimum of fifteen (15) school days.

If a Constitution for participation in this activity has been filed by the activity's sponsor with the principal, that Constitution may contain penalties for misconduct in addition to or greater than those described in the Student Code of Conduct, Discipline Management Plan, or this Form. By their signatures below, each participant and participant's parent/guardian, indicates that they have received, read, understand and agree to be bound by that Constitution and this Form.

Notwithstanding, and in addition to consequences outlined in the Constitution, each sponsor(s) has the discretion to increase the length of suspension outlined above, or permanently remove a student from participation, when the student's misconduct involves violating academic integrity, weapons, drugs, alcohol, hazing, or threats to the safety of students or teachers and/or in the discretion of the school officials, the student's continued participation in the activity would be detrimental in representing the activity, school, or community. If a student is suspended or withdrawn from participation in an extra-curricular/co-curricular activity, the student and parent/guardian will be notified as soon as reasonably practicable. Disciplinary actions may be appealed according to Board Policy FNG (LOCAL), which can be accessed on the District web page (ahisd.net), or upon request from the principal's office.
